Step Eight – Made a list of all persons we had harmed, and became willing to make amends to them all.

In the past, I hurt a lot of people: family, friends, and even innocent spectators. Step Eight gets me ready to make amends to them. It's like Step Six because it shows me that getting ready is just as important as doing it. Part of getting ready is putting the names on a list. It's easy for me to say that everything was "their" fault. But writing names down helps me to face up to the fact that I hurt other people. Making my list won't mean a thing unless I'm willing to do something with it. I can put it off, and make a lot of excuses, but my Higher Power won't let me do that. He wants me to be willing to apologize so that when the time comes to make my amends, I'll be a lot more honest and sincere. Things to Think About: I've hurt a lot of people and I feel badly about it. I know I need to apologize to them, but I have to be willing to do it before I can really mean it. Step Eight gets me there. When I've put together a list and I've really thought seriously about making my amends, I'll be ready to say an honest, "I'm Sorry!"

Traditions Eight – Al-Anon Twelfth Step work should remain non-professional, but our service centers may employ special workers.

Following the guidance of Tradition Eight, we help those we love by sharing who we are and leading by the power of example, not by acting as experts and offering unsolicited *advice*. This Tradition also makes allowance for the times when a relationship needs the assistance of professional expertise.

Concept Eight – The Board of Trustees delegates full authority for routine management of Al-Anon Headquarters to its executive committees.

What we learn in Al-Anon helps us rise above the restricting minutiae and view ourselves and our lives with a new perspective. By keeping it simple and taking "First Things First," we get past the trees and can appreciate the forest. This doesn't mean that we dump all those nagging chores. We just learn to keep them in their place so they don't smother us. In the service structure of Al-Anon, it is essential that an overview is maintained. Vision is needed to address policy questions, supply leadership, meet financial obligations, strengthen the interrelationship of the groups, and carry the message of Al-Anon around the world. With this responsibility in mind, as Al-Anon grew and the work of the World Service Office increased, the Board of Trustees, which administers it, appointed a large committee to advise them. This advisory board was replaced in 1964 by the Conference of Delegates. The Conference then became the permanent guardian of Al-Anon's Traditions and services. The overall view was established.
