### Step Seven – Humbly asked Him to remove our shortcomings.

My dad is the alcoholic in my family. He started drinking long before I was born. Even though his problem was older than I am, I took on the responsibility for it. And I couldn't handle it. I worried about my dad so much that I made myself sick. I got so depressed that I was close to suicide. I was put into a hospital where the doctors told me that I had to stop worrying about my dad. They told me that I needed to concentrate on taking care of myself. When they let me out of the hospital, they told me to go to Alateen. In Alateen it took me over a year to get to the Seventh Step. The Seventh Step was the easiest step I've eve taken in the program. It took me just a few minutes to ask God to please help me stop worrying so much about my dad. Now it's not just my dad that I love a lot. I also love everybody in Alateen. But I don't have to worry about anyone. From "Courage To Be Me page 144"

## Tradition Seven – Every group ought to be fully self-supporting, declining outside contributions.

I never thought much about Tradition Seven, which says that every group ought to be fully self-supporting. I thought it referred only to paying the rent. But recently I was involved with a group that maintained itself financially and still was not fully self-supporting because no one would commit to service. I already held several positions, and when

my various terms expired. No one was willing to take my place. I made what felt like the responsible choice for myself and stepped down anyway. The meeting closed. In my opinion, a group that cannot fill its service positions is not fully self-supporting. Today, in other, more flourishing groups, I have a greater appreciation of my responsibility to this Tradition. I believe that as we nurture our groups, we nurture and empower ourselves. We can make a contribution; we can make choices that help us to allow healing in ourselves and others. *From* "Courage to Change, page 251"

### Concept Seven – The Trustees have legal rights while the rights of the Conference are traditional.

If all issues could be resolved through harmonious cooperation, life would be ideal. We can reach for this ideal in our private lives through keeping our conscience and our actions in balance. While we become aware of our intuitive needs, we can't let our emotions rule us. Our actions must come from a sensible viewing of what is right to do. When we acknowledge our heart, and temper it with judgment, the two become one and life flows more smoothly. The Concepts point the way to this ideal of harmony in the service structure. Concept Seven defines the balance of powers between the Conference (the conscience of Al-Anon with traditional rights) and the Trustees (who are responsible for Al-Anon's actions because of their legal responsibility for Al-Anon's funds and services). The two work well together when each recognizes its role and neither is "tempted to make a 'rubber stamp' of the other". From "The Concepts, P-57, page 16"
