# Step Ten – Continued to take personal inventory and when we were wrong promptly admitted it.

In Step Ten one of the words that stood out in my mind was "continued." It reminded me that I began my personal inventory in Step Four. Likewise the words, "and when we were wrong, promptly admitted it," reminded me of work I had already done in Steps Five, Eight and Nine. All of these Steps represented a thorough, personal housecleaning for me. But I knew my house wouldn't stay clean if I didn't do a few daily chores. In order to work Step Ten, the experience I acquired in the nine Steps that led up to it showed me what I needed. Specifically, I needed to recognize my powerlessness over other people. I needed to believe that God could help me. I needed to make the decision to allow my Higher Power to take care of me. I needed to inventory my behavior so I could recognize my good points as well as my bad.

# Tradition Ten – The Al-Anon Family Groups have no opinion on outside issues; hence our name ought never be drawn into public controversy.

Tradition Ten states that our groups have no opinion on outside issues, and thereby avoid

public controversy. We can apply this to our relationships by minding our own business and not arguing about issues that have nothing to do with us. We realize that others have as much as to their opinions as we do to ours, and we give them the same dignity and respect we want for ourselves.

Concept Ten - Service responsibility is balanced by carefully defined service authority and double-headed management is avoided. Responsibility! Do we take on more than our share or shirk it completely? Authority! Do we dictate and dominate or passively cave in? Al-Anon shows us how to find the right balance between responsibility and authority in our personal lives so we do our own job and no one else's, so we know when to yield and when to stand up for our rights. Concept Ten describes how such balance is achieved in service for fellowship. Relationships are harmonious when persons know exactly what their area of operation is and how much leeway is allowable for individual initiative. Authority can never be divided into equal halves -"double-headed management." When there is confusion in definition, if two people are trying to do the same job, when there is no communication, or if the person in charge is unwilling to delegate suitable authority, then personal clashes result and nothing gets done.

The service structure of Al-Anon is built on the premise that each individual counts. To avoid "avoid over-bossing," each member in service is considered a trusted servant with a clearly defined job to do and the authority to do it.
